For surely I know the plans I have for you, says the Lord, plans for your welfare and not harm, to give you a future with hope. Jeremiah 29:11

A little over five hundred years before the birth of Jesus, when the people of God were in exile in Babylon, an alien and hostile land, Jeremiah told them that God had plans for their welfare: a future of hope.

#### MINISTER'S MESSAGE

As I reflect upon 2023, I am amazed at the changes I have seen in St. Andrew's Presbyterian Church. We have deepened our faith as we have struggled with change. We have not allowed the fact that we are small in numbers dampen our enthusiasm for God's church. We have remained faithful to the cause of Christ by continuing to serve.

Servanthood is at the heart of St. Andrew's which is demonstrated in many ways. For one thing. . . the coffee is always on for Sunday morning and somebody always bring treats . Then the men pitch in and wash up all the dirty cups after our fellowship time.

Even though we are still considered to be a small congregation, we have welcomed 3 new members into our fellowship and we have had 2 ladies renew their commitment to Christ by renewing their memberships with us and demonstrating their faithfulness to the ministry of this church.

We baptized one adult and five children.

We have begun to establish a pastoral care team which will be visiting shut-ins. Last year seniors enjoyed a fellowship afternoon once a month and that will continue. Be it a small group, it is always lots of fun.

We are dreaming of welcoming youth into our building for hot dogs at noon on Fridays. Is this the beginning of some kind of youth ministry?

I am thankful for the excellent leadership of Marianne Hyatt. The children love her! We look forward to the time when she will need helpers as our Sunday School grows.

It has been delightful to work with our secretary Katharine Currie. Her efficiency in exercising her role is unmatched!

St. Andrew's has played a leading part in bringing churches in Petrolia together for joint ministry projects:

The Walk With the Cross with a Good Friday Service following took place last year and will take place again in 2024, with the walk culminating at St. Andrew's. Rev. Katherine will be the speaker and a joint choir will perform.

The services in the park last summer were a huge success and will happen again in the summer of 2024. The schedule is already set!

We are presently embarking on a Blessing Bags Project together.

The churches of Petrolia have been invited by the town to provide a joint worship service in Greenway Park on August 18 th at 10 a.m. to celebrate the town's 150 th anniversary. The pastors are working hard on this service. Pastor Alex Craig will be the speaker and once again there will be a joint choir.

Our challenge for 2024 is to continue to reach out, to offer hope to all people, to dream big, and to follow the will of God in all things. God has given us eternal life through our faith in Jesus Christ. John 3:16.

It behooves us to offer the Good News to others so that people can find hope in Jesus. Let us continue to be the Good News church that we are...the church with the 'open door'. To God be the glory!

If Session approves, that candidate (and their family) will be invited to come to St. Andrew's, stay in the community for the weekend, see the area, lead worship on Sunday and have social events within the congregation. The congregation will vote after the service...and we will see what the Lord is leading us all towards.

This is an exciting time, much promise. I would ask you to be praying for the Search Committee, the Session, and the prospective new pastor, for discernment, joy and wisdom. Thank you for your support and prayers for me. I am grateful for the ongoing, faithful, enthusiastic leadership of Rev. Katherine Hawley (and Paul!). With you, I am looking forward to what this year will bring as we serve the Lord in Petrolia and beyond.

### **MINUTES OF 2023 ANNUAL MEETING**

The congregation met on Sunday March 5 th at 12:05 PM

There were 30 present, 26 members and 4 adherents.

Rev. Chris O'Reilly opened the meeting with a prayer.

It was agreed that Rev. Chris would lead the meeting.

Nominations were opened for the position of recorder for the meeting. Gladys Ottens nominated Gini Newman, seconded by Larry Zavitz. Gini accepted. Carried

Rev. Chris reviewed the messages from herself and from Rev. Katherine.

Gini moved that the minutes of the March 20, 2022 annual meeting be accepted as printed. Seconded by Mike Belan. Carried.

Bob Newman spoke to the message from the session.

Financial statements were reviewed. There was clarification of where the Knox Dawn proceeds were entered (in the trustee's investment report). Balance sheets were presented for the general account, the restoration account, session fund, and Ladies of the Church account. Bob informed the meeting that the bank had notified the office that the Ladies account was inactive and that session had recommended that it be closed, transferring the balance to the general account. Moved by Dick Ottens, seconded by Wendy Dunn that the financial reports be accepted. Carried

Committee reports were reviewed next

- 1. Financial resource team. It was clarified that the surplus is mainly due to the Knox Dawn proceeds. It is also noted that insurance was paid December 2021 and January 2023, so no payment is shown for 2022. The wishes of the former members of Knox Dawn for the disbursement of the proceeds are noted. Appreciation was shown to them for their gift and for their faithful service and contributions to St. Andrew's. Rev. Chris spoke briefly on the PAR program which makes the job of the finance committee easier. Rev. Chris expressed thanks for the generosity of the congregation.
- 2. Sunday School report Marianne Hyatt explained her process for when there are no children present. They continue to follow the story line unless a particular lesson in time sensitive (Thanksgiving or Christmas). They have been studying the New Testament. They have looked at the life of child when Jesus was a child, and have studied his baptism and are now moving into his ministry.
- 3. Property Team Dick Ottens reported that new carpet should be installed in the sanctuary this week, but inability to get the plaster repairs completed is holding up other work. The new microphone appears to be working well.
- 4. Mission team Pam Belan explained a new mission Kelly's Cupboard at LCCVI. Norm Holbrook told a little about TearFund Canada. We have also added the Petrolia Community Refrigerator for this year. Rev. Katherine asked if TearFund was active with indigenous people and Norm explained a group who have been helping to reintroduce bison herds on the prairies.

Budget for 2023. Rev. Chris spoke to the change in the stipend (a housing allowance has been added). Moved by Gladys, seconded by Larry that the budget be accepted. Carried.

Rev. Chris explained that the Presbytery was making changes and that as of June the Rev. Dick Eric van Dorsten would be our interim moderator.

The floor was opened for discussion. –

1. Was the Alpha program still under discussion? Rev. Chris gave a brief outline of its origin as an evangelical outreach but that it is also used by current church goers to deepen their understanding. Rev. Katherine has spoken with Alex Craig & Carol Ferguson and they agree that this would be too much for the pastors to lead at this time.

Rev. Chris offered thanks to the members of session, and to Katharine Currie and Gini for recording the minutes, to Marianne for good work with the children, Rev. Katherine and others for music ministry, Cindy and Dave Vandenberghe for their custodial work, Katharine Currie for all of her efforts, Kelsey for the PowerPoint and the online streaming, Rev. Katherine for her leadership and offered a pray for Paul's recovery.

Marjorie Douglas offered thanks to Rev. Chris for her leadership.

Kelsey McMurphy and Sue Walters agreed to review the books next year.

Larry moved adjournment at 1:10 PM

Rev. Chris closed with a prayer.

#### **ANNUAL SESSION REPORT 2023**

The year 2023 was again a year of change.

Current active session members are Mike Belan, Pam Belan, Pam Irwin, Bob Newman, Dick Ottens, Gladys Ottens and Larry Zavitz. We continue under the excellent leadership of our interim moderator Rev. Christine O'Reilly.

Rev. Katherine Hawley stepped back from part time ministry due to health concerns in 2023 and finished the year as stated pulpit supply. In August we held a congregational meeting to determine how to move forward and the decision was to follow the process to call a full-time minister and a search committee was formed under the leadership of Rev. Christine O'Reilly.

We were able to worship in our sanctuary throughout this year as well as continuing to offer live stream of the services via You Tube. We appreciate the number of you who worshiped from your homes and continued to support us.

In person Bible study also continued. We studied a series Unshakeable Hope from Max Lucado originally with Rev. Katherine and then finished by Daniel Bennett who also lead studies on Psalms and the Gospel of John.

Rev. Katherine continued to play the piano, organ or guitar during worship. Brian Krale plays the organ 2 Sundays per month and Ina Hodgin plays the piano on 2 Sundays. Rev. Katherine continues to work with the St. Andrew's singers to add new music to our services.

We were again able to participate with the local ministerial. There was a joint Good Friday Service at the Baptist Church and there were 8 Sunday evening services in Victoria Park, shared by the Baptist, United, Anglican and Presbyterian Churches.

A special thank you is offered to Ken and Jean McGregor and Dick Ottens for ensuring that a crop of soybeans was harvested on the 4 acre property on LaSalle Line. The revenues went to the Canadian Foodgrains Bank via the Bluewater Growing Project specifically marked for PWS&D projects. The Canadian government matches the funds 3:1.

Thank you to the Belans who decorated our sanctuary for the Christmas season. They worked extra hard this year because we participated in a home and church tour sponsored by the Anglican Church. I can't begin to list all of the things they have done for us this year. We are truly thankful for all of their efforts.

At this time session would like to thank our paid staff – Rev. Katherine, Marianne and Katharine for the exceptional efforts they make on behalf of our congregation. Special thanks to Kelsey McMurphy, Dick and Gladys Ottens and Pam and Mike Belan who assist with sound and live streaming.

We have also benefitted from youth volunteering for our church. Abe Ottens, Danton Webster, and Dylan Webster all assisted with the sound and Dylan also played drums for us. Audrey Newman helps in the nursery and Ethan Currie has kept our grass cut.

### **FINANCIAL RESOURCES TEAM**

This team is responsible for the receiving and disbursing of the offering of the Congregation. The team is made up of Bob Newman (Member of Session), Church Treasurer (Ann DenBoer), Office Administrator (Katharine Currie), Larry Zavitz (Member of Session) and at least one member from the congregation (Janice Currah).

#### BUDGET TIME is upon us again.

We ended 2023 with a **surplus of \$10,635.40** in our operating account. The cause of our surplus, in part, is due to a generous donation of \$10,000 by a member of our congregation. Without that donation, we would have barely broken even in 2023.

In April 2023, \$10,000 was withdrawn from the Knox-Dawn investment. This was done at the direction of the Knox-Dawn members and in accordance with their wishes on how to see funds from the sale of Knox-Dawn disbursed. As discussed at last year's annual meeting, their wishes were:

- a) A donation of \$5,000 to Rev Harvey Osborne for seeing them through the hard times and his support up to the end;
- b) A donation of \$5,000 to Rev Katherine Hawley for her extra hours and service; and
- c) The remainder of the funds to be donated to St Andrew's and used as St Andrew's sees fit.

The donations were made to both Rev Harvey and Rev Katherine and the remaining balance remains invested in a GIC.

In June 2023, \$15,900 was withdrawn from one of the Schuldt investments to cover the cost of carpet installation in the sanctuary, nursery, administrative office and elevator area.

PAR offerings are a preauthorized payment that comes out of your bank account automatically each month. Call Office Administrator Katharine in the office at 519-882-2400 to sign up for automatic payments or to increase your offerings for 2024. Just a SMALL increase in your weekly offering makes a HUGE difference in the bottom line of our Church. We are in this together!

In 2023 we needed to bring in \$2,194.50 per week to sustain monthly expenses.

### To sustain the Church overhead for 2024, we will require \$2,346.32 on a weekly basis.

We thank those who have been attending worship and giving of their time and talents, and invite those who have not been attending to come and join us in worship. Thank you for your support of OUR CHURCH!

### Team responsibilities are as follows:

- 1. Be responsible for the preparation of the annual operating budget for Session and the congregation's approval in consultation with affiliated pastoral charges.
- 2. Oversee the stewardship of the operating budget.
- 3. Encourage the members of the congregation in the stewardship of their financial resources.
- 4. Provide statements to Session on a monthly basis for information and review.
- 5. Be responsible for the operations and duties of the Church Administrator.
- 6. Follow the guidelines as set out in the different Funds of the Church.
- 7. To invest and disburse trust funds as directed by the Trustees.
- 8. To make the books available for the annual review by the Reviewers.
- 9. To issue tax receipts according to the policy approved by Session.
- 10. To dialogue with the property team on the financial side of property issues.
- 11. To prepare a written report of the Finance Team's activities for our newsletters and a report to be included in our Annual Report.
